Memorandum of Agreement

The objective is to continue developing and expanding a framework of cooperation between the two parties to develop knowledge exchange program based on either Party providing the business opportunities and the party assisting in taking the opportunities to logical conclusion and executing the same or vice versa both in Ireland and Kazakhstan.

Disputes

This MOA shall be governed by and be interpreted in accordance with the laws of the United Arab Emirates. Both parties agree to resolve any disputes amicably and with the same level of respect that this MOA was drawn upon and will proceed with mutual and responsible negotiations resulting in an arbitration agreement.

Confidentiality

Each Party shall keep confidential and shall not, without the written consent of the other Party, disclose to any other party the terms of this Agreement or any documents or other information furnished directly or indirectly by the other Party in connection with this Agreement.

Termination

This MOA may be terminated by both parties but need to be seated together to resolve the issue and if not agreed it will go to the competent authority for the resolution.

Validation

This agreement is valid for five (5) years with automatic renewal. If both parties decide to terminate the agreement, they must close all pending projects as is mutually agreed.
